1. DESCRIPTION

IMWITOR[®] 742 is a non-ionic O/W co-emulsifier with an estimated HLB of 5-6, that can be used especially as a dispersing and wetting agent and for an improved solubility of hydrophilic substances in lipophilic systems. It is 100% natural, vegan, RSPO MB certified and produced exclusively in Germany.

It is a partial glyceride of a blend of mono, di and triglycerides, mainly of caprylic and capric acid. IMWITOR® 742 is a white-yellowish, pasty crystalline mass with a characteristic odour. It melts at about 25°C to form an oily, yellowish liquid. It does not contain unsaturated components and is therefore stable against oxidation even at elevated temperatures. As partial glyceride of C8/C10 fatty acid, IMWITOR® 742 has a typical bitter taste.

2. APPLICATION

IMWITOR[®] 742 can be used in different cosmetic formulations, e.g. as a dispersant for active ingredients in anti-acne creams, as a wetting agent in colour cosmetic formulations or a refatting agent in shower gels.

Due to its lipophilicity IMWITOR[®] 742 is miscible with all fats and oils and very slightly soluble in water (about 10%).


FORMULATION HINTS

- Recommended concentration
 - Dispersing, wetting agent 1 3%
 - □ Solubility improvement in oils: 1 25%
 - Refatting agent: 0.2 -1%.
- Add IMWITOR[®] 742 to the oil phase.
- It can be incorporated into cold process surfactant systems, providing a thickening effect. It is an alternative to ethoxylated refatting agents such as PEG-6 Caprylic/Capric Glycerides (SOFTIGEN[®] 767) or PEG-7 Glyceryl Cocoate.
- IMWITOR[®] 742 can occur in different forms/consistencies, ranging from a crystalline solid or partly solid to liquid or paste, depending on the monoester content and the ambient temperatures. Due to this and in order to obtain a homogeneous product, it is recommended to melt the bulk before using the product.
- Recommended pH value 4 7.5.

4. HANDLING AND SHELF LIFE

The shelf life for IMWITOR[®] 742 is at least thirty-six months if the product is stored below 25°C in a dry place in original, tightly closed containers, protected from light and moisture.
