1. DESCRIPTION

IMWITOR® 960 K is a partly anionic classic self-emulsifying emulsifier for O/W emulsions with an estimated HLB of 9-12. It is 100% natural, vegan, available in RSPO MB certified quality and produced exclusively in Germany.

IMWITOR® 960 K is a white to light yellowish solid, waxy mass (flakes) with a mild, faint odour. The product has a high storage stability as it has no unsaturated components.


FORMULATION HINTS

- Melting point: approx. 56 61°C
- Recommended concentration of IMWITOR® 960 K for rich creams and butters: 2 7 %
- Applicable for hot/hot processes
- The self-emulsifying properties of IMWITOR® 960 K minimise the need for other emulsifiers in formulations. The addition of 2-3% stearic acid as a second emulsifier and
- Recommended pH value: pH 6.8 8.5

4. HANDLING AND SHELF LIFE

Long-term storage: the shelf life for IMWITOR® 960 K is at least thirty-six months if the product is stored below 25°C in a dry place in original, tightly closed containers, protected from light and moisture.
