IMWITOR[®] 960 K is a white to light yellowish solid, waxy mass (flakes) with a mild, faint odor. The product has a high storage stability as it has no unsaturated components.

FORMULATION HINTS

- Recommended concentration of IMWITOR® 960 K: 2 7 %
- Melting point: approx. 56 61°C
- Applicable for hot processes
- The self-emulsifying properties of IMWITOR[®] 960 K minimize the need for other emulsifiers in formulations. 2 3% of stearic acid can be added as second emulsifier.
- Recommended pH value: pH 6.8 8.5



HANDLING AND SHELF LIFE

The shelf life for IMWITOR[®] 960 K is at least thirty-six months if the product is stored below 25°C in a dry place in original, tightly closed containers, protected from light and moisture.
